Co-Alliance is a cooperative organization formally established in 2006, but has roots going back to the 1920s. Co-Alliance has two bulk plant facilities in Butler County, Ohio and provides delivery of heating oil and other petroleum products. They have previously been known as Farm Bureau, Butler Landmark, and Harvest Land.

WHAT THIS MEANS FOR YOU:

- **AUTOMATIC DELIVERY CUSTOMERS:**

YOU DO NOT HAVE TO DO ANYTHING. Your deliveries will continue automatically by Co-Alliance, and you will pay Co-Alliance for any deliveries they make. This is scheduled to begin **December 1, 2021.**

- **WILL CALL DELIVERY CUSTOMERS:**

Beginning **December 1, 2021**, please call the Seven Mile Co-Alliance Location at **(513) 863-1414** to schedule any home heat or petroleum delivery.

- **TERMS OF PAYMENT / DISCOUNTS:**

Deliveries made by Co-Alliance will have Payment Terms/Discounts established and set by Co-Alliance.

- **EQUAL PAYMENT PLAN PARTICIPANTS:**

Beginning **December 1, 2021** your Equal Payment Plan statement will be sent by Co-Alliance, and you will need to pay Co-Alliance. If you currently have a **CREDIT BALANCE** with Stephenson Oil, that **CREDIT** will be transferred to Co-Alliance, and you can continue deliveries and payments uninterrupted through Co-Alliance. If you prefer to have your **CREDIT** balance refunded to you from Stephenson Oil, please contact Stephenson Oil.

- **CREDIT CARD PAYMENT CUSTOMERS:**

Stephenson Oil Company will not share any credit card information you have previously provided with Co-Alliance for security purposes. If you want Co-Alliance to have your credit card information on file, you will have to contact Co-Alliance and provide that information.
